The 2013 AFricaCongress had the theme, 'AFTER SO MUCH ADVOCACY, WHAT NEXT? And was co-hosted by the Rgional Vice Presidents for Africa Barrister MrsEzinwaOkoroafor and Barrister Gladys Fri MbuyahLuku.

FIDA Africa Regional Congress is usually a forum to renew contacts, re-contact, build coalitions, develop and share strategies on urgent issues that are critical to the promotion, protection and preservation of the rights of women and children in the continent. It was on this premise that the 2013 FIDA Africa Regional Congress was organized. The congress was unique. The collaboration of the two Regional Vice Presidents to jointly organize a congress demonstrated the kind of solidarity and spirit that women human rights activists in the region and all FIDA country branches should exhibit.

In her own message, FIDA Historian Mrs. Veronica Odunuga encouraged FIDA to continue to raise the awareness on violence against women and girls as a human rights issue. Dr.GraceOngile, the UN entity for Gender Equality and the Empowerment of Women (UN Women) Representative to Nigeria and ECOWAS in a message to the Congress wished the delegate happy deliberations and sent her Theme Paper for the benefit, following her inability to attend on account of travel challenges.

The Congress was formally declared open by the Republic of Cameroon's Minister of Women's Empowerment and he Family, MmeAbenaOndoa Nee Obama Marie-Therese, who congratulated FIDA in its role in promoting women's rights and agreed that after so much advocacy, 'The time for action is now'

MallamSanuseLamidoSanuse - the governor of central bank, Nigeria, presented the Key Note Address covering gender and development issues, from a purely economic perspective his speech highlighted the various interventions and reforms in the banking industry which has impacted the lives of women in the industry in particular and Nigeria in general. It was in recognition and appreciation of his leadership role, innovative and initiatives and programs for the benefit of women that he was presented with the maiden 'FIDA GENDER CHAMPION AWARED'
