# AFRICAN REGIONAL CONGRESS (EKO 2004)

Held in Lagos Nigeria From June 7-11, 2004

ursuant to my election as Regional Vice President (Africa) at the FIDA Biennial Convention held in Manaus, Brazil from September 5<sup>th</sup> to 9<sup>th</sup> 2002, I was charged with the responsibility of organising a Congress within the African Region.

The FIDA African Regional Congress tagged **"EKO 2004"** was successfully held between Monday June 7 and Friday June 11, 2004 at

### Theme

The theme of the Congress was "Women's Rights - From Awareness to Implementation". The choice of this theme was borne out of the realisation of the fact that partly on account of FIDA activities, much awareness had been created on the issues affecting women in Africa. In several African countries today, various gendersensitive laws have been passed.

Unfortunately, non-adherence to these laws by the relevant government agencies and individuals as well as their ineffective and inefficient application, have rendered the benefits meant to be attained therefrom, a mirage. It was realised that this situation was as true in Nigeria as in other parts of Africa, even if in varying degrees.

In view of the foregoing, we realised that the main challenge was how to move from creating awareness to the phase of implementation.

Monday June 4, 2004 was reserved for arrivals, registration of participants and a cocktail party. An impressive formal Opening Ceremony was held on Tuesday June 5, 2005; Prof. Ignatius A. Ayua, SAN OFR - Solicitor General of the Federal Republic of Nigeria delivered an address and declared the Congress open on behalf of His Excellency Atiku Abubakar, the Vice President of the Federal Republic of Nigeria.

The ceremony featured welcome addresses by FIDA International President Puan Sri Saraswathy Devi and Regional Vice President (Africa) Mrs Veronica Odunuga. Goodwill messages were also received from Chief Akinlolu Olujimi SAN (Hon. Attorney General of the Federation and Minister for Justice); Chief Mrs. Oluremi Tinubu - wife of the Governor of Lagos State (represented by Mrs. Gbajabiamila) and Chief Wole Olanipekun the President of the Nigerian Bar Association

Mrs. Elsie Thompson Country Vice President of FIDA Nigeria, (currently a Judge of the High Court of Rivers State of Nigeria) delivered the keynote address titled - *An Overview of Women's Rights in Nigeria*.

Joy Ogwu; Chief Mrs. Stella Ugboma - Past Country Vice President, FIDA Nigeria and Past Director, FIDA International; Hon Justice (Mrs.) Ifeyinwa Nzeakor - Judge of the Federal Court of Appeal.

## **Participants**

Participants were drawn from the FIDA Cameroon (Mrs. Betty Luma and Justice Helen FonAchu), FIDA Ghana (Mrs. Gladys Attobrah), FIDA Uganda (Norah Matovu Winyi - (Chairperson) and Annet Koote) and members from various state branches of FIDA Nigeria.

Also in attendance were Nigerian Female lawyers, members of the National Council of Women Societies, the Police Officers' Wives Association, Women from faith based Associations and others. Officers and members of the Nigerian Bar Association were also present, thus ensuring participation by both sexes and in this case, relevant stakeholders. Country Experiences and papers presented by these participants helped in enriching the quality of the discourse at the Congress.

### Closing

The final day of the Congress featured a press Conference at which a Communiqué was issued, as well as a rally, which focused on the Prevention of Mother to Child Transmission of HIV/AIDS. The day was rounded off with the grand finale, which was a Black and White Ball at the Golden Gate Restaurant, Ikoyi, Lagos. This event also served as a forum for the formal presentation of the Global Villager Award to Her Excellency Chief (Mrs.)
